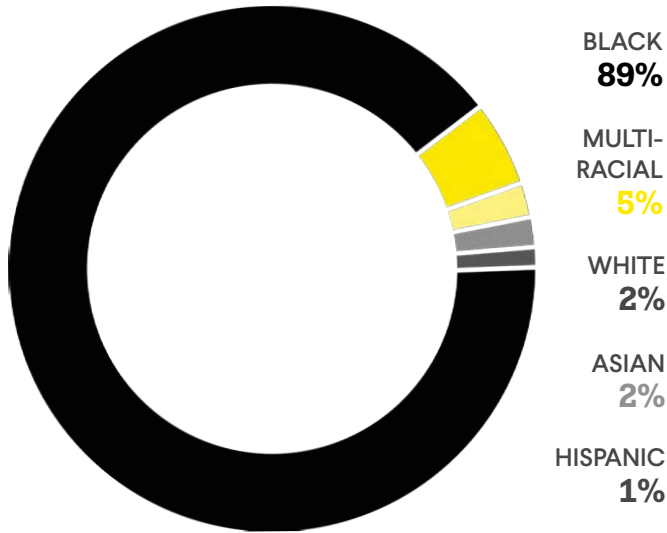

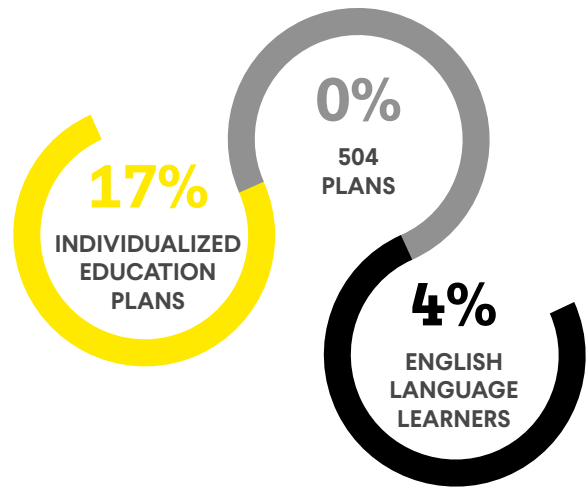

## STUDENT DEMOGRAPHICS



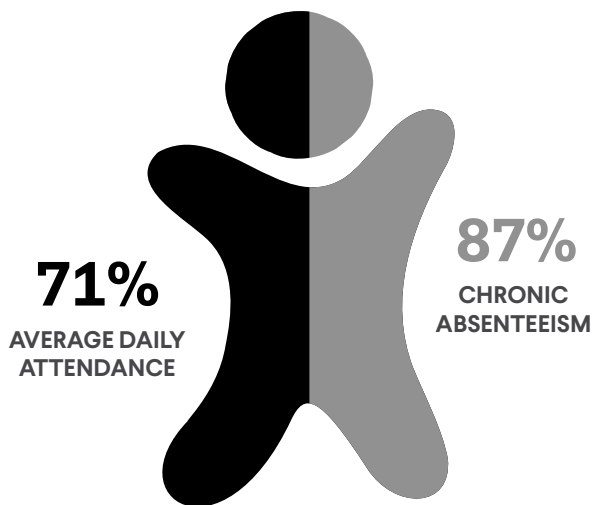

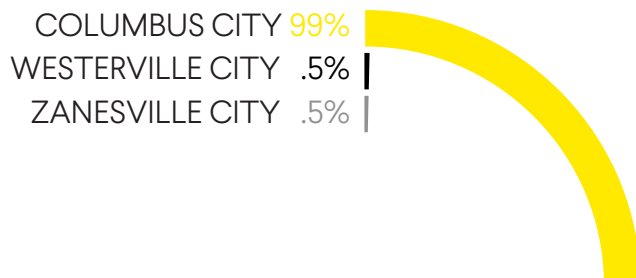

Emerging from the pandemic, NCPA achieved its goals as measured by i-Ready and a 3-star rating on Progress for meeting state expectations for student academic growth.

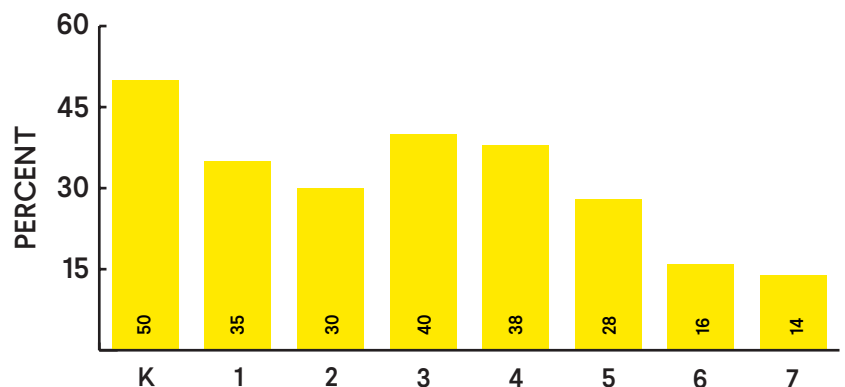
